Among these are the Critical Infrastructure Protection (CIP) Cyber Security Standards designed to ensure the protection of cyber assets critical to the reliability of North America’s bulk electric systems. Under the governance of the Federal Energy Regulatory Commission (FERC), the corporation develops and enforces NERC reliability standards for planning and operating the bulk power system and minimizing the risk of system disturbances.
